The leaders began by emphasising the value of the UK-Greek relationship as we mark the 200th anniversary of Greece's war of independence. They agreed to work to strengthen it further in areas including trade, education and tourism.

BCC trade update



The Border and Protocol Delivery Group published a new version of the <u>GB Border Operating Model</u>, outlining the processes for inbound GB border controls phased in from 1 January 2022. Key dates for importers and EU suppliers include:

- **1 January** (start of pre-notification for all animal origin and plant products consignments, end of easement on suppliers' declarations);
- **1 July** (safety and security certificates now required and start of documentary and physical checks for meat and meat products at GB border control posts);
- 1 September (start of checks for dairy and dairy products); and
- **1 November** (start of checks for fish and composite food products).



Discussions on the Protocol in Northern Ireland continue between UK and EU officials. Lord Frost spoke about the possibility of more momentum in the talks. Prospects of any speedy suspension of the Protocol have receded somewhat. Current easements continue in place between GB and NI on goods movements.

18 November 2021

BCC Trade Update



The UK government has issued its <u>Export Strategy</u>, which has at its centre a 12 point plan to raise UK export levels, with reference to UK Export Finance, Trade Academy and other measures. Shevaun Haviland participated in a Ministerial roundtable on the strategy on Monday with International Trade Secretary Anne-Marie Trevelyan MP. Some comments included in The Department of International Trade's (DIT) <u>press release on the strategy</u>.



DIT also issued the first in a series of <u>papers on trade</u> which sets out the economic underpinnings of the Export Strategy, the UK's particular strengths in goods and services exports in the years ahead and how increases in exports contribute to the UK government's cross-cutting agenda on Net Zero, productivity and levelling up.



BCC met with the Paymaster-General Michael Ellis, to discuss business concerns on UK-EU trade, including VAT, the expiry of easements on rules of origin certification, and SPS rules.



HM Revenue and Customs (HMRC) wrote to 155,000 companies as part of their campaign on proving origin of goods to/from the EU after 1 January 2022.



The World Trade Organisation (WTO) published its <u>World Trade Report 2021</u>. It outlines the effects the pandemic had on global trade and makes the case for more trade co-operation between countries. The WTO Ministerial Conference (<u>MC12</u>) gets underway on 30 November with services, SMEs, and sustainability policy looking the most likely areas for agreement.



The UK's National Security and Investment Act 2021 – new guidance

The UK government has made a significant upgrade to investment screening, for national security purposes. The National Security and Investment Act (NSI) ensures predictability and transparency, while mitigating any risks to national security.

The new system will come fully into force on **Tuesday 4 January 2022.**

Businesses and investors are encouraged to get ready for the changes, with new guidance published.

11 November 2021

BCC Trade Update



After a meeting with the Paymaster-General Michael Ellis last week, BCC has taken up issues with the Cabinet Office such as cross-border VAT and the expiry of the easement on proof of origin on UK-EU trade. New implementation guidance on the usage of CE and UKCA marking from January 2023 will be available soon from the Department for Business, Energy and Industrial Strategy (BEIS).



Lord Frost made a <u>statement on negotiations with the EU</u> in the House of Lords. He said the discussions still had some way to go before other actions in relation to the Protocol in NI would be undertaken. The BCC has pressed both sides to reach an agreement to avoid risks of EU-UK trade disruption this winter.




A revised paper on UK Common Frameworks was released by the Cabinet Office. Common Frameworks are those areas of regulation which were previously underpinned by the EU rules which intersect with devolved competences and are agreed to maintain common approaches within the UK's internal market.



At the World Trade Organisation (WTO) in Geneva, further work has been completed on the <u>agenda for micro, small and medium sized businesses</u>, including a new digital trade information platform for businesses, ahead of the Ministerial Conference at the end of this month. BCC will be looking carefully at the outputs from this.

- UK economic growth picks up in August as service sector output accelerates.

- OBR forecasts a stronger UK economic recovery and an improved fiscal position.
