Την Τετάρτη 15 Νοεμβρίου 2023 πραγματοποιήθηκε επιτυχώς η Έκτακτη Γενική Συνέλευση του Ελληνοβρετανικού Επιμελητηρίου, με τη χρήση ψηφιακών μέσων (διαδικτυακά).

Συγκεκριμένα, τις εργασίες της Γενικής Συνέλευσης παρακολούθησαν μέσω τηλεδιάσκεψης, μεταξύ των μελών του Επιμελητηρίου περισσότερα από 120 υψηλόβαθμα στελέχη των μεγαλύτερων επιχειρήσεων από όλους τους κλάδους της ελληνικής οικονομίας. Η ηλεκτρονική ψηφοφορία για την έγκριση των προτεινόμενων τροποποιήσεων του Καταστατικού, καθώς και για την ανάδειξη των 15 νέων μελών του Διοικητικού Συμβουλίου (10 Ελλήνων και 5 Βρετανών υπηκόων σύμφωνα με το Καταστατικό του Επιμελητηρίου), πραγματοποιήθηκε ψηφιακά μέσω του πληροφοριακού συστήματος ΖΕΥΣ της ΕΔΥΤΕ, που διασφαλίζει την ακεραιότητα της διαδικασίας και την αδιάβλητη διεξαγωγή μυστικών ψηφοφοριών με αμιγώς ηλεκτρονικό τρόπο.

SME EXPORTERS TREADING WATER

- BCC's Trade Confidence Outlook sees no improvement in Q3 of 2023 as half of all SME exporters (49%) saw no change in overseas sales, and a quarter (25%) reported a decrease.
- Just over a quarter of exporting SME firms (26%) saw their overseas sales increase in the quarter.
- It is almost five years (Q4 2018) since the proportion of firms reporting increased sales was higher than 30%.
