New BCC President-elect, Andy Haldane CBE

Andy Haldane CBE has been elected the new President of the British Chambers of Commerce (BCC), succeeding Baroness Martha Lane-Fox CBE as her three-year term concludes in accordance with the BCC Articles of Association.

Andy was elected by representatives of the accredited Chamber Network at the **BCC's Annual General Meeting as of Wednesday 15 October**. He will take up the role on **Sunday 1 February 2026**.

Baroness Martha Lane-Fox CBE will stand down as President on 31 December 2026, at the conclusion of her three-year term, ahead of Andy taking up the role on Sunday 1 February 2026.

As President, Andy will work alongside Shevaun Haviland CBE, BCC Director General, and Sarah Howard MBE, BCC Chair, to represent the interests of Chamber business communities at a critical time for the UK economy.

New Law 5222/2025 for the National Custom Code and other important tax provisions

On 25 July 2025, Law 5222/2025 (Government Gazette: A' 134/28.07.2025), titled "National Customs Code and Other Provisions – Pension-related Provisions," was enacted. This law brings substantial changes to Greece's customs and tax framework, completely replacing the existing National Customs Code in order to align with EU customs regulations and international treaties ratified by Greece, and to address evolving needs in global trade and technological developments.
